

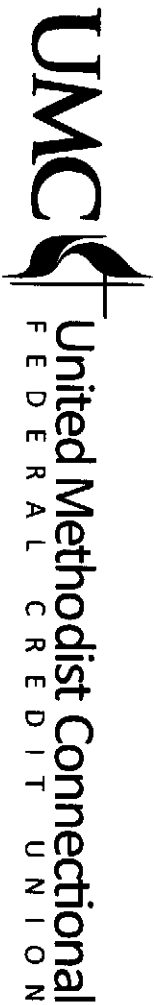


Have A High School Graduate This Year?
